Handgun Shooting



All participants must pass the following minimum certification criteria to receive a Certificate of Completion.

From the Holster or appropriate concealment method:

- **3ft proficiency**
 - Facing down range and standing “*at ease*” draw and fire 2 rounds with strong hand only. Unload and show clear prior to re-holstering.
- **5yd proficiency**
 - Facing down range and standing “*at ease*” draw and fire 5 rounds with strong hand supported re-load fire 5 rounds. Unload and show clear prior to re-holstering.
- **10yd proficiency**
 - Facing down range and standing “*at ease*” draw and fire 5 rounds re-load and fire 5 rounds. Unload and show clear prior to re-holstering.
- **15yd proficiency**
 - Facing down range and standing “*at ease*” draw and fire 5 rounds from standing position re-load and fire 5 rounds from the kneeling position. Unload and show clear prior to re-holstering.

- **Items to bring**
 - Photocopy of driver’s license
 - Copy of Certificate of Naturalization or Permanent Resident Card (if born outside of U.S.)
 - Firearms you intend to list on your CCW Permit
 - **Strong side holster** with sturdy belt. Holster recommendation; **Blackhawk Serpa** holster utilizing the belt attachment not the paddle attachment. This is a Level II retention holster and when utilized properly and as designed is an excellent training holster for proper presentation and finger placement on the firearm. This is only a recommendation. Holsters that are **not acceptable** include soft nylon or leather, pocket, appendix, crossdraw, behind the back, shoulder, etc. All options will be discussed at course for your future consideration
 - Minimum of two magazines with dbl mag pouch or two speed loaders w/dbl pouch (*revolver*)
 - Concealment jacket, vest or shirt
 - Eye and ear protection
 - 200 rounds of ammunition for 8 or 16 hr course
 - Sack lunch and snacks
